MELZER'S FUEL SERVICE INC. NOTICE OF DATA PRIVACY EVENT

Painesville, OH, February 26, 2026 – Melzer's Fuel Service Inc. ("MFS") is providing notice of an event that may affect the privacy of certain individuals' information. We take this incident very seriously and are providing information about the incident, the response to it, and resources available to individuals to help protect their information, should they feel it appropriate to do so.

What Happened? On or about September 17, 2025, MFS became aware of unusual activity in its email environment. Upon becoming aware, MFS promptly began an investigation into the scope and nature of the suspicious activity and retained legal counsel and third-party forensic specialists to investigate the unusual activity. That investigation revealed that certain information may have been viewed and copied by an unauthorized individual as part of the event. This activity occurred between August 31, 2025 and September 29, 2025. MFS then began a comprehensive review of the data set to determine what sensitive and/or personal information was impacted and to whom it related. On February 19, 2026, MFS finished its review of the impacted information.

What Information Was Involved? The information potentially impacted by this event vary by individual and not all data elements were impacted for every individual, but may include name, Social Security number, Tax Identification Number, driver's license number, state identification number, passport number, financial account number, payment card number and means of access, medical record number, medical information, and email address with password.

What We Are Doing. We take this event and the security of personal information in its care very seriously. Upon learning of this event, we moved quickly to investigate and respond to the event and notify potentially affected individuals. As part of our ongoing commitment to the security of information, we are reviewing and enhancing existing policies and procedures to reduce the likelihood of a similar future event. We are notifying impacted individuals for whom we have a valid mailing address via U.S. mail and offering them credit monitoring and identity protection services. We are also notifying applicable regulators.

How Will Individuals Know If They Are Affected By This Incident? A notice letter is being mailed to individuals whose information was determined to be in the affected files, for whom a valid mailing address is available. If an individual does not receive a letter but would like to know if they are affected, they may call our dedicated assistance line, detailed below.

Whom Should Individuals Contact For More Information? If individuals have questions or would like additional information, they may call our dedicated assistance line at **1-866-557-5489**, between the hours of 8:00 a.m. to 8:00 p.m. Eastern time, Monday through Friday. This excludes all major U.S. holidays.

What You Can Do. We encourage individuals to remain vigilant against incidents of identity theft and fraud by reviewing your account statements, explanation of benefits forms, and monitoring your free credit reports for suspicious activity and to detect errors. Under U.S. law individuals are entitled to one free credit report annually from each of the three major credit reporting bureaus. Individuals may also contact the three major credit bureaus directly to request a free copy of their credit report, place a fraud alert, or a security freeze. Contact information for the credit bureaus is below:

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit

freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you may need to provide the following information, depending on whether the request is made online, by phone, or by mail:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
